II. Old Business

- a. Gooseberry Point- Lauren Jennings and George Baker came to the meeting with a proposal of gooseberry point. - b. The Board as Assessors reviewed the tax commitment and signed the Certificates of Assessments for the 2019 tax commitment.
- c. Quick Claim deed was signed and notarized for the back liens of the Gooseberry property.
- d. BHBT had paperwork for the board to sign to add J. Lunt to the accounts.
- e. Storm Doors- J. Lunt is still in the process of finding storm doors to replace the current office outside door.
- f. Ferry Generator- board member S. Brake was approached by R. Bost, he stated to her that while he was at the ferry terminal, a state worker approached him stating that our generator was too small for the ferry ramp, and that it had caused damage to the ramp and parts of the electrical would need to be replaced due to this. They will no longer allow the town to use the current generator, it needs to be removed and a larger one needs to replace it. S. Brake was taken back by this, the generator has not been used in a few years to work the ramp, as well as the state did not come directly to the town with this matter, instead just told a citizen. S. Brake is working on trying to find out more answers.
- g. Island Fellow- The board was presented with the idea for an island fellow project next year. It would be to work on the town's solid waste issues. Improving the dump area and our recyclables.
- h. Payroll service- Daniel Swain has asked the board to consider doing a payroll service. The board is not sure if it is correct for the town and needs more information before agreeing.
