## Meeting called to order at 12:45pm by C. Hodgkins

- I. Approval of Minutes

- II. Old Business
  - a. Bond- The town has a bond, with \$2600.00 left to pay on it. We pay \$100 dollars a month.   - e. Floats- We have had a concerned citizen come to the board about the floats, and the pin that can come undone and make them uneven. The board has also discussed the possibilities of new floats. Board members will gather quotes to see the cost of building a new one.
  - f. Tax maps need to be updated. We also need to add the old FFDC land to the maps with map and lot numbers
  - g. FFDC Land- The land has been transferred to the town. After discussing with the board it seems the best way to go is to have soil test done on all of the land the is available to sell, as well as having them marked so that when we do show the land we can give a clear idea of their boundaries.
  - h. The furnace in the municipal building has been out. We thought it was because the fuel ran out ( the gages did not work properly ) then it was a pump. Kevin Lunt ordered the part we need and D. Dunphy will have someone help him install it.
