ARTICLE 1: TO CHOOSE A MODERATOR TO PRESIDE AT SAID MEETING.

Robert Roxby nominates Duncan Bond, Paul Charpentier 2nd

3 votes yes 0 opposed, DUNCAN BOND ELECTED MODERATOR

ARTICLE 2:

TO SEE IF THE VOTERS OF THE TOWN OF FRENCHBORO WILL LOAN \$1,000.00 FROM THE MUNICIPAL BUILDING ACCOUNT TO THE FRENCHBORO MAIL ASSOCIATION ACCOUNT.

EXPLANATION: THE FIXED RATE THE P.O. RECEIVES FROM THE USPS (1,550.00 PER MONTH) IS SO CLOSE TO THE ACTUAL EXPENSES INCURRED ON A MONTHLY BASIS THAT THE CHECKING ACCOUNT IS AT THE EXTREME RISK FOR OVERDRAFT WHICH RESULTS IN MORE COSTS CHARGED TO THAT ACCOUNT.
