Selectboard Meeting Minutes July 11<sup>th</sup> 2022 5:00pm

Meeting called to order at 5:20 pm by Chris Hodges (Joe Lunt and Eric Best present)

- I. Approval of Minutes
  - Motion by J. Lunt to approve the minutes from May 11<sup>th</sup>, 2022, second by C. Hodgkins. **Motion Passed**
- II. Old Business
  - a. Discussed status of land sales, which have been terminated. On separate matter, decided to inquire of Alison King if she can help on the town's foreclosure sale to see if the language regarding tax map versus metse and bounds is appropriate.
  - b. Approved a \$20 expenditure to pay Jackie and Charlie to repair a school post struck by an auto.
  - c. Took under advisement a Town of Sydney description for an administrative post that was approved at the 2022 town meting and must be filled. Discussed how this might be a remote job. Eric to develop a template for discussion before Aug. 1 (next meeting).
  - d. Agreed on process by which Paul Saxby will remove/relace certain appliances in the teacher's house for which he will prepare a final quote for labor and materials.
  - e. Discussed whether to create a town of Frenchboro credit card for purchasing and decided not to at this time.
  - f. Discussed list of insurance related compliance issues and decided to ask who in town might contribute to bring various conditions into compliance.
