Meeting called to order at 5:02pm by Joe Lunt, seconded by Chris Hodgkins **Motion passed**

I. Old Business

- a. Discussion of updates by Dan DeBord and Eric Best on regaining access to the town website and repopulating it. Motion by Eric Best to direct Dan DeBord to continue updating the website with current information and make obvious changes now, while also working on a survey to send to the community at large asking what information the community would like to see on the website in the future. Motion seconded by Joe Lunt **Motion passed**
- b. With Dakota Dunphy in attendance, discussed his prior inquiry into purchasing the town cardboard disposal trailer. Dakota Dunphy offered a bid of \$350 to purchase the cardboard trailer, along with agreeing to dispose of the current debris inside the trailer himself. Chris Hodgkins motions to accept the bid, seconded by Joe Lunt **Motion passed**
- c. Discussion of funding and plan options for head of the harbor - consideration of whether to keep the job small and simply fix the present issue, or to pursue grant funds to make it a larger project that might be more enticing to bidders, potentially raising the road for flood risk mitigation along with fixing the current road and culvert wash issues. Motion by Joe Lunt to direct Dan DeBord to reach out to Hancock Regional Planning Commission to gauge potential for their help with project planning or technical assistance for potential grant applications, seconded by Chris Hodgkins **Motion passed**

- b. Discussion about improvements to the town's current solid waste facilities and operations. Eric Best motions that Joe Lunt discuss the subject with Rick Turner and ask if Rick has any interest in spearheading solid waste improvement efforts. Seconded by Joe Lunt **Motion passed**
- c. Request submitted by Sarah Saxby and others to host their Thanksgiving meal in the fire hall due to home space limitation. Motion to approve with invitation to make nominal
